- 3.2 Under this agreement partner has no right to distribute Soffront CRM to anyone else other than Partner's own contacts.

4.0 Intellectual Property.

Intellectual properties and confidential information belonging to each party are the sole property of the party and any rights to access, dissemination and/or use granted to the other party may be revoked at any time with or without cause or prior notice.

5.0 Relationship:

Soffront and Partner agree that no joint venture, partnership, employment, or agency relationship exists between them as a result of this Agreement or Partner's use of the Soffront's Software or Services.

6.0 Compliance:

Partner shall comply, with commercially reasonable efforts, that any third parties performing sales or referral activities on its behalf comply, with all applicable foreign and domestic laws, governmental regulations, ordinances, and judicial administrative orders and shall not engage in any deceptive, misleading, illegal or unethical marketing activities, or activities that otherwise may be detrimental to Soffront, its customers, or to the public.
